**SEREMBAN:** SD Guthrie Bhd has signed an agreement with Eco World Development Group Bhd and NS Corp to develop an integrated industrial park, known as Eco Business Park 7 (EBP7), with an estimated gross development value of RM2.95bil.

The EBP7 project, which is located on 1,195 acres of land in Bukit Pelandok, Port Dickson, will be carried out in Parcel C of the Malaysian Vision Valley 2.0 (MVV2.0

development over nine years.

In a joint statement, the parties involved said EBP7 will leverage on the synergies between the three entities – SD Guthrie's strategically located land, EcoWorld's expertise and experience in industrial park development as well as NS Corp as the state-appointed coordinator and custodian of the MVV2.0 masterplan.

"The project aims to attract local and foreign investments, create high-value jobs and drive the state's economic growth

agenda.

"It will also offer access to a proposed Nilai Labu Expressway that will connect the area to key infrastructure and logistics hubs such as the KL International Airport, Port Klang, Nilai and the North South Expressway," the parties said.

EBP7 will feature, among other things, industrial lots, ready built factories and other commercial properties tailored for high impact industries including those in aerospace, electrical and electronics, logistics and biotechnology.

EcoWorld will hold 55% of the EBP7 while SD Guthrie Land Ventures Sdn Bhd, a subsidiary of SD Guthrie will hold 30% and

NS Corp 15%.
